<u>Cut off rules:</u> The cut-off criterion was chosen based on the used PCR. According to the used PCR, more than 99 % of flows were included.



All materials and energy flows were modelled based on real tracked consumption of material and production bilances of energies. For subcontractors, data about their consumption of materials and energies for the particular operation were included as well. VOC emissions were allocated based on the weight of the final product across the whole production. No secondary fuels or materials are used in production. Generic process data for production of input materials and components were used.

<u>Electricity consumption</u>: Generation of electricity consumed within ROBE lighting s.r.o. production was based on the Czech residual electricity grid mix. GWP-GHG indicator of the used residual electricity grid mix is 0,643 kg CO2 eq./kWh.

Characterisation factors: Characterisation factors are based on Environmental Footprint 3.1. (EF 3.1).
